#### HOA Frequently Asked Questions

#### • What is an HOA reserve fund?

HOA fees are usually divided into two parts: One portion goes toward monthly expenses, and the remaining money goes into a reserve fund, to save for long-term repairs and replacements such as retention pond/drainage repairs. Reserve funds also cover emergency expenses that arise when natural disasters, vandals, or just the unavoidable wear and tear strike. A great example of this is when one of the neighborhood signs is hit by a vehicle.

#### • What is an assessment?

When our community is hit with extreme maintenance expense, a homeowner's insurance will cover some of it, but whatever's left will have to be paid by our HOA.

Typically, in these cases the HOA will tap the reserve fund, which may become depleted as a result. As a result, the HOA board may require the homeowners in the community to pay a special assessment bill above and beyond your monthly HOA fee. Luckily, though, these assessments are typically temporary until the reserve is back up to a comfortable level.

#### • What happens if I can't pay the HOA fees?

Most lending institutions take the HOA fee into consideration when they write up your mortgage. In other words, they evaluate your monthly income compared with your monthly expenses, and they won't make a loan on the desired property unless they feel you can safely cover everything: your mortgage payment, taxes, and HOA fees.

But life happens. If you lose your job or are unable to pay your HOA fees, you might be able to work something out with the HOA board. Be sure to talk to the HOA Board **before** you miss even one payment. If you fall too far behind, the consequences could result in a lien or collection which will affect your credit rating.

Palmetto Pride sponsors a statewide Litter Busters Hotline so you can report litterbugs. The program, made possible thanks to the cooperation of the Department of Natural Resources and the Department of Public Safety, works like this:

You spot someone tossing litter from an automobile. You immediately call...

877-7LITTER (754-8837)

...and report the location, time and the litterbug's license number. You can also report a violation from the Palmetto Pride website using the form provided on the website.

The litterbug will receive a letter from the Department of Public Safety informing him or her that they can't get away with littering in South Carolina. The letter will explain that if a law enforcement officer had witnessed the littering, it could have resulted in a serious fine or even jail time.

#### Homeowner Association Dues

River Oaks Homeowner Association Dues are currently \$105.00 per year and are due January 31st of each year. The dues are applied as part of an annual budget approved by the homeowners to cover expenses associated with operation of the association, maintenance of entranceways and common areas, and Park Forest and Appian Way street lights. A detailed listing of expenditures can be found under the annual budget. If you have questions after your review of the budget on our ROHA Web page, please contact your subdivision board member or any available board member.

#### Vehicle Registration in South Carolina

If you meet any of the below criteria, you must register your vehicle in South Carolina:

- Have children enrolled in a public-school district
- Established residency in the state
- Working full time in the state and not maintaining another residence in another state
- Have been driving a vehicle owned by another person for an accumulated period of 150 days (Absentee Owner)
- Permanently employed in this state

Note: The Motor Vehicle Registration and Licensing Ordinance does not apply to Active Duty Military.

New South Carolina residents have 45 days to transfer their vehicle registration to this state.
