Be Aware

- Always be aware of your surroundings, vigilant of activity around you and attentive to individuals approaching, walking with a purpose and with confidence.
- Do not allow yourself to be distracted by activity such as talking on your cell phone, listening to music or reading.
- Try to travel with others, walk in well-traveled areas, and at night in well-lit areas.
- Do not display large amounts of cash when paying for items, and do not display excessive jewelry.
- If you see a person or group that makes you feel uncomfortable, attempt to distance yourself from them; cross the street, walk in another direction, go in to a business or residence.

Protect Your property

- Don't carry large amounts of cash. Carry your valuables safely. Don't display valuable items (e.g., iPods, iPhones, cash), when walking to and from your destination.
- Enable GPS locator features on your cell phone.
- Write down the make, model & serial # of the phone and keep that info in a safe place.

If You Are Robbed

- If someone demands your property and displays or implies in any way that they have a weapon, don't resist. Your physical property isn't worth getting injured over.
- Do not pursue the thief. Put distance between you and the thief.
- Report any robberies or suspicious activity to the Police.

If you are told you are part of a mandatory evacuation, don't wait get out of the way of the storm. Make sure you know your evacuation routes! As someone who has been through Hugo and several other close calls and a couple of minor hits, it only takes one to kill you.

Safety is everyone's responsibility!!!

Our first responders are the best and do all they can to keep us safe and out of harm's way. Thank you to all of you which live in a community as well as the many that do not. We have had little problems here at Rivers Oaks and pray to have less as time moves on. Our fire, police and medical personal come when we ask, do what is needed all in a day's work but they cannot be here all the time as North Charleston is a large area and most would say they are somewhat understaffed. How can we make this place we call home even safer? Is more police and fire people the answer? I know that most are now thinking "up go the taxes" and I would agree. If only we could do something without more boots on the streets. I believe we can with little impact to all of us with just a few changes.

Most of us come and go in and out of Rivers Oaks at least once a day, many of us more. Some folks work daylight some overnight, we have neighbors that work 2^{nd} shift and some that work from home. We have many that are retired. We have the "boots on the street" if we would only use them, them being all of us. All of us means ALL not some. We cannot think someone else will or is doing it for me.

If, just if everyone would learn and know what is normal in his or her four or five house radius this would help in identifying what maybe a problem, see something say something.

To learn what is going on in the hood all we have to do is pay attention. I know this maybe hard at first but should you not be "paying attention" anyways? Some of us are driving, some walking or riding a bike etc. I find that most of the time coming in or going out I am on auto-pilot. I too see people every day that must be doing the same.

Here is what I think may help. Drive the speed limit which is 25 miles per hour not 45.

Put your phone down for the five minutes it takes to get in or out of our community, just till you get to Dorchester Road.

Look around and see what you may have been missing in the past. If you see something that looks out of place or just not right, say something or call someone like the Police.

House alarms, car alarms, fire or smoke alarms. We hear them all the time wereever we go we hear alarms. We have become immune to the sound of danger, this is not good. Let's all try and change this. Next time you hear a car alarm or any alarms take a few seconds to look and listen. Don't just say "I wish they would turn that off. If it was your car or house would you not want someone to make sure it's a false alarm and not your house burning?

Is your House an Extended stay?

I see them all the time on the other end of Ashley Phosphate People coming and going but they are staying somewhere. The hotels down by the interstate charge an incredible rate for people to stay there. The people come and go and rarely talk with those staying in the next room. I am sure they have reasons, "Too busy," Don't have time," and "I do not want to associate with those people," are just a few that come to mind. Being paying guests in a hotel I would say that those may be fair positions to take. I will also be among the first to say that I take some of those same positions when I am out of town myself. I am there for work or family after all right? But I do say "Hello" and often wish well to those strangers. I will bet you do too. I ask; Who does it in the neighborhood? How many people wave at or talk to our morning walking group that walks Park Forest almost every morning between 6:30 and 7:30? I myself always wave and the slim gentleman with the hat always acknowledges my effort. There are others out there that walk and perhaps I should be more assertive to acknowledge them maybe roll the window down and say "Good morning," as I drive by on my way to work in the mornings. Some days it is just the simple things that cost us nothing we do to recognize each other in our daily lives that makes our neighborhood a great place for a home instead of just a long-term Extended Stay.

Why is it important to keep a personal record of serial numbers on personal items?

If you become the victim of a burglary, many times the only way that the personal property stolen from your residence can be tracked, located and returned to you is through a record of the serial numbers on the property. Serial numbers on stolen property are entered into state and national computer databases that can be accessed by officers and detectives who are investigating recovered property to determine if the property is stolen and can be returned to the owner. In addition, pawn shops, a possible destination for burglary suspects with stolen property, are mandated by law to record the serial numbers on property being pawned. The serial numbers on pawned property is regularly compared to the serial numbers on stolen property. If a piece of your personal property does not have a serial number, you should attempt to engrave a personal identification number somewhere on the property that is not easily visible and does not damage the property, but at a location on the personal property that can still be accessed by an officer or detective.

Do not use your Social Security number as your personal identification number. Using a Social Security number as a personal identification number on your property only increases the chance that you will become the victim of identity theft.

In addition to recording serial numbers or personal identification numbers on your personal property, you should consider taking photographs of the personal property and/or video recording the interior of your residence. In the unfortunate event that your residence is burglarized, the photographs and/or video recording can be extremely useful in providing a description of personal items that are unique or difficult to describe in words, e.g. pieces of jewelry, or in verifying insurance claims.

Remember to maintain the records of your personal property, including lists of serial numbers, photographs or video recordings, in a secure location that may not be at your residence. This is especially important in the event that your residence is seriously damaged or destroyed by fire and you need verification of ownership of personal property damaged or destroyed.

Raising Dues

It is not too early to talk about this and I believe me it is not a subject which the board, who are also home owners, want to talk about. As you are aware, our current dues are \$105.00 a year, the lowest of any community in our area. If everyone pays their dues, we would have an income of \$70,770.00. As of June 3, 2019, the ROHA has spent over \$45,000.00. The rest of this year's expenditures match the first half and we will remain solvent. Having said that, in order for us to maintain services and appearances we have to raise dues. Also, we have another problem. The insurance costs that covers the ROHA property and board has been drastically raised. The cost went from \$4,100.00 to over \$8,300.00 and the deductible went from \$3,000.00 to \$25,000.00. In the past we have utilized the Emergency Fund to cover any deductible. So we need to raise the emergency fund to be able to cover any misstep.

In order to cover emergencies and meet operating costs as they stand today, the dues need to be raised from the current \$105.00 to \$175.00. This is what will be needed to cover the ROHA operating cost (Approximately \$94,000.00) and boost our emergency fund from the current \$10,000.00 to \$25,000.00.

Remember these numbers really only work if all 674 home owners pay their share and unfortunately approximately 10% of our home owners do not. The board will continue to be as frugal as possible while maintaining the appearances of our neighborhoods.


