Golf Cart

Golf cart permits are available at any SCDMV branch office. The permit allows a licensed driver to operate a golf cart during daylight hours on a secondary highway or street within four miles of his residence or place of business.

To obtain a golf cart permit, you must:

- Complete Form GC-2. Golf Cart Permit Registration
- · Provide proof of insurance for the golf cart
- Provide the driver license number of any licensed driver who will operate the golf cart
- Submit a fee of \$5.00.

The law pertaining to the issuance of Golf Cart permits (56-2-105) has been amended effective October 1, 2012. The amendment requires golf cart permits to expire five years from the date of issuance. Golf cart owners holding golf cart permits on or before October 1, 2012 will have until September 30, 2015 to obtain a replacement permit. The amendment also discontinues the requirement of a listing of all operators of the golf cart and operators must be a licensed driver 16 years of age or older.

SCDMV will implement changes required by law in January 2013. Until these changes are implemented, DMV will follow current procedures and use the existing forms for issuance of Golf Cart permits. Permits issued prior to implementation must be replaced by September 30, 2015

Roof Mounted Satellite Dishes

If you have Direct TV or Dish Network and the Satellite receiver is mounted on your roof and perhaps was installed a few years ago, it might be advantageous to have a professional roofer check the mounts and your roof for any damages.

We recently hired a contractor to come repair wood rot on our fascia boards. Not giving this much thought as if you live in South Carolina you will at some point have some rotted wood to replace. As he climbed the ladder to inspect the area more he noted the damage was coming from an unsuspected source, the roof mounted receiver. It had been installed and we simply forgot about it. Reception was great because it was higher than the tree line and it was out of sight. That was the beginning of the end. We started the repair process by contacting the roofer who had installed our new roof years before for his evaluation. Which was "you've got a big problem up there!"

We had to contact our provider for a damage claim then wait for them to contact the contractor in Florida who hired the local installer to come to give his evaluation and determine who was at fault. After 15 days someone finally arrived and determined the mounts were loose which caused water to intrude creating a huge rotted area in the wood under the shingles which without repair would have created an even bigger problem if the weight of the receiver had fallen through the roof and into our home.

Fortunately, the roofer we hired before the receiver was installed stood behind his work came back to make the necessary repairs. Yes, I paid for the repairs, but I was reimbursed from the contractor in Florida.

If you have roof mounted satellite receiver dishes get them checked out. You may just save yourself some grief especially with hurricane season upon us.
