Mission Statement

The River Oaks Homeowners Association (ROHA) was started by a few individuals that were concerned about maintaining property values and the overall appearance of our community.

The association has representatives from each of the eleven subdivisions (Ansley Point; Appian Landing I, II, III; Marsh Hall; Marsh Side; Palmetto Plantation; River Chase; and Woodington I, II, III). The first Board meeting was held in March of 1997. The mission of the ROHA is:

- a) To provide a venue for preservation and enhancement of the value of the property of the
- b) To promote and protect the civic welfare of the River Oaks community, and particularly of the members of the association;
- c) To carry out its purpose without engaging in any business activities or pursuits, and without taking action for pecuniary profit;
- d) To provide for the enhancement and maintenance of entryways to the River Oaks community from Dorchester Road, the entryways to individual subdivisions, the roadside areas along Park Forest Parkway and Appian Way, and of existing roadway islands, and the improvement of street lighting and other safety enhancing measures, and may enter into necessary agreements and obligations needed to address those concerns, upon approval of the membership, by majority vote, of a budget sufficient for the purposes.
- e) To assist subdivision organizations regarding violations of covenants and restrictions provided it is feasible to do so.

Covenants and Restrictions (C&Rs)

The C&Rs vary slightly from subdivision to subdivision but all were established by the developers and attached to the respective lot's deed in an effort to maintain the harmony of external appearance of each subdivision. C&Rs are enforced through a property management company. You should receive a copy of your subdivision's C&Rs and the Association Bylaws at the time of your closing. Board of Director and General Meetings

General Meetings are normally held twice a year and dates are published in the newsletter and with signs posted in the neighborhood. The General Meetings are normally held the last Monday of January and the last Monday in October at 7:00 pm at Faith Assembly Church – 3001 Landing Parkway.

Board of Director Meetings are held the first Thursday of every month at 7:00 pm at the Ashley River Fire Department, 8045 Dorchester Road 29418. Board meetings are open to homeowners however you must contact the secretary ([Michelle Jackson - mjackson4@sc.rr.com](mailto:mjackson4@sc.rr.com)) at least one week prior to the meeting to be added to the agenda.

Planning and Codes Enforcement

The following are strictly prohibited as a part of Dorchester Code:

- Commercial vehicles, unlicensed, or unregistered vehicles are not to be parked on any lot, land, or street within the River Oaks Community
- Large items that need to be disposed of should not be placed at the street more than 24 hours prior to the arranged pickup. Items left at the street for an extended period of time may be ticketed by Codes Enforcement.
- It is the responsibility of the homeowner to contact their preferred trash removal company for weekly service or to remove large unwanted items.

Homeowner Association Dues

River Oaks Homeowner Association Dues are \$105.00 per year and are due in January. The dues are applied as part of an annual budget approved by the homeowners to cover expenses associated with operation of the association, maintenance of entranceways and common areas, and Park Forest and Appian Way street lights. Animal Control

Dorchester County does not allow animals (dogs and fertile cats) to run at large. See Sec 4.7 of the Code of Ordinances. “Upon conviction, any person violating this chapter shall be fined an amount not to exceed \$500.00 or 30 days in jail, or both.
